



Privacy Notice

Dance Maniax is committed to protection and respecting your privacy and personal data that you provide for the purpose of your membership of the club. Dance Maniax is the Data Controller for this information and is responsible for storing and processing the data you provide.

What personal data we hold on you

You provide us with information about you by filling in a registration form, when you register with Dance Maniax, The information you give includes, your name, date of birth, address, e-mail address, phone number, emergency contact information and school. We also ask for relevant health information or any relevant information you feel we need to be aware of to ensure your safety.

During events and dance sessions we may take photographs or video footage of performances with your consent (Registration and Photography Form).

Why we need your personal data

The reason we need your Data is so that you can attend classes, when you register with the club. Our lawful basis for processing your personal is that we have a contractual obligation to you as a member to provide the services you are registering for.

Reasons we need to process your data include:

For membership and club management

- processing of forms and payments;
- to provide information about club activities, or invitation to social events;
- club letters promoting club activity; and
- publishing events or performances

For obtaining appropriate Licenses and for event organisers

- Sharing personal data with the local authority that provide Dance Maniax with license for you to be able to perform.
- Event organisers need names of performers to gain access to the event

Any special category health data we hold on you is only processed for the purpose(s) of ensuring the safe running dance sessions and will only be shared in with relevant medical professionals in the event of an incident requiring medical intervention. We process this data on the lawful basis of consent. Therefore, we will also need your explicit consent to process this data, which we will ask for at the point of collecting it.

Any photos or video footage collected is used for promoting the club and may be used on the Dance Maniax website or social media page, and website or social media pages of events that Dance Maniax are performing at. We process this data on the lawful basis of consent. Therefore, we require your explicit consent to process this information and will ask you specifically about photographs and video on our registration form.

Social Media/ Website

The club has a facebook page (please search Dance Maniax on Facebook). All members are free to join the facebook page. If you join the facebook page, please note that provider of the social media platform(s) have their own privacy policies and that the club do not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data on the club social media pages. The club also has a website www.dancemaniax.co.uk.

When completing the registration form we ask you to provide explicit consent for the use of photos' and video that may be used on the Dance Maniax website or facebook page.

Who we share your personal data with

The club only shares your name, date of birth, and school with the Local Authority in order to obtain performance license.

How long we hold your personal data

We will hold your personal data on file for as long as you are a member with us. We ask that you update your information with us should information change. Any personal data we hold on you will be securely destroyed after five years of you no longer being a member.

Your rights regarding your personal data

As a data subject you may have the right at any time to request access to, rectification or erasure of your personal data; to restrict or object to certain kinds of processing of your personal data, including direct marketing; to the portability of your personal data.
